Dear Members,

I am pleased to place before you the 34th Annual Report of DR. JIVRAJ MEHTA SMARAK HEALTH FOUNDATION, for the year ending on 31st March, 2018, along with some of highlights of the progress and activities of the Foundation, covering the period of this report.

I am pleased to inform that during the year, the foundation has received the Research Corpus Donation of Rs.5,76,85,108/-, achieving the total corpus fund of Rs.4067.31 lacs. Out of that the foundation has utilized Rs. 3715.00 lacs for acquiring the Gross Block of Fix Assets, for which the corpus donation is being received. It is the motto of the foundation to upgrade the research department with the latest Medical equipments and upgrading the Healthcare unit infrastructure.

Continuous efforts are being made in upgradation of the basic infrastructure and I am pleased to inform that during the period, D Wing, C Wing, Pediatric Ward, Ground Floor main foyer and Administrative block has been fully renovated. The foundation is planning to complete renovation of the entire premises in short period. The Foundation during the year under reference has purchased Major Medical Equipments such as Portable Bronchoscope, Multipara Monitor, Ophthalmic Equipments and highly Equipped Modular Operation Theater.

The Foundation has been able to provide financial assistance for healthcare to the poor, to the tune of Rs. 39,45,443/- which includes a relief received by the patient of Foundation to the tune of Rs. 28,70,850/- from “Dardionu Rahat Fund”, Rs. 4,38,061/- received from “Bharat Vikas Parishad Dardionu Rahat Fund” and Rs.6,36,532/- direct relief from the “Late Shree Ratubhai Adani Poor Patient Relief Fund”.

Our Research activity component has continued to do the excellent job during the year of report under the guidance of Research Advisory Committee and Ethics Committee of Research, before which are placed proposed projects every year for approval or otherwise, the interim reports of the ongoing research projects and the final report of the completed projects. During the year under report eight newly proposed research projects were placed before the Research Advisory Committee. Interim reports of four ongoing projects and final reports of four completed Research Projects were also placed before the Research Advisory Committee. The Institution has been involved in Clinical, Laboratory, Field research projects etc. Efforts are being made to organize on and average minimum one program for the public awareness in the various socio economy and health awareness.

It was our continuous effort to strengthen the operation of the pathology department, which in current time is a prime factor for research as well as health care activities. I

am pleased to inform that with the excellent team work, the foundation is able to achieve Blood Bank License for the period of five years. Hence forward the Pathology Department and Blood Bank with Component Laboratory shall be able to operate independently.

Being a Research Institution it is the primary requirement to get continuous registration with Scientific Industrial Research Organizations (SIROs). I have great pleasure in informing that our foundation has been able to get the renewal registration of SIROs for the further period of three years i.e. from 01/04/2018 to 31/03/2021.

We intend to continue and widen the spectrum of Research & Health care activity, continuing our efforts of development in future.

Our Foundation has continued its efforts during this financial year, as in the past in its mission of serving and providing good health care to the community at large and undertaking Research activities with support of all concerned.

The Foundation is fortunate to get the support of the Donors and I am thankful to our Donors for their generous support to the Foundation. I appeal them for the similar support in the coming years.

I am thankful to the Benevolent Donors, Members of the Board of Trustees, Governing Council, Members of Research Advisory and Ethics Committee and Honorary Consultants for their kind help and support to this Foundation. I am also happy that all Medical, Paramedical, Administrative and all other Categories of staff have sincerely contributed to the development of the Foundation.
