Dear Members,

I am pleased to place before you the 36th Annual Report of DR. JIVRAJ MEHTA SMARAK HEALTH FOUNDATION, for the year ending on 31st March, 2020, along with some of highlights of the progress and activities of the Foundation, covering the period of this report.

I am pleased to inform that during the year, the foundation has received the Research Corpus Donation of Rs. 85,36,000/-, achieving the total corpus fund of Rs. 4549.09 Lacs. Out of that the foundation has utilized Rs. 4121.93 lacs for acquiring the Gross Block of Fix Assets, for which the corpus donation is being received. It is the motto of the foundation to upgrade the research department with the latest Medical equipments and upgrading the Healthcare unit infrastructure.

As stated in my last annual report, continuous efforts are being made in up gradation of the basic infrastructure and installation of Medical Equipments. I am pleased to inform that we have separated CSSD department [Central Sterile Supply Department] from Operation Theatre complex to 3rd floor with latest equipments. We have upgraded research department with the facilities to sit 20 research coordinators with internet facilities. We have fully air-conditioned basement OPD for comfort of patients. We have installed 2 more lifts. One lift exclusively for Dialysis patients. We have shifted our Dialysis department from ground floor to third floor with raising the capacity from 8 machines to 11 machines and four Isolation rooms for kidney transplants patients. We have located R.O. Plants on terrace raising the capacity from 1000 liters to 3000 liters. We have renovated mortuary and back side compound wall. We have formed drug formulary for our Hospital. We have displayed LED sign board stating our name on the roof for the Hospital. We are planning to renovate - upgrade General ward and Laboratory. Also planning for MRI facility.

The Foundation has been able to provide financial assistance for healthcare to the poor, to the tune of Rs. 48,17,196/- which includes a relief received by the Foundation to the tune of Rs. 32,84,000/- from "Dardionu Rahat Fund", Rs. 7,32,097/- received from "Bharat Vikas Parishad Dardionu Rahat Fund" and Rs. 8,01,099/- direct relief from the "Late Shree Ratubhai Adani Poor Patient Relief Fund".

Our Research activity component has continued to do the excellent job during the year of report under the guidance of Research Advisory Committee and Ethics Committee of Research, before which are placed proposed projects every year for approval or otherwise, the interim reports of the ongoing research projects and the final report of the completed projects. During the year 5 projects are completed and 10 projects are ongoing.

It was our continuous effort to strengthen the operation of the pathology department, which in current time is a prime factor for research as well as health care activities. Blood Bank

Department has shown the satisfactory progress. During the year nineteen camps were organized at various places of the city and has collected about 1511 units of blood.

I am pleased to inform that the Dr. Jivraj Mehta Smarak Health Foundation has Scientific Industrial Research Organizations (SIROs) registration from 2018 to 2021.

We intend to continue and widen the spectrum of Research & Health care activity, continuing our efforts of development in future.

Our Foundation has continued its efforts during this financial year as in the past, in its mission of serving and providing good health care to the community at large and undertaking Research activities with support of all concerned.

The Foundation is fortunate to get the support of the Donors and I am thankful to our Donors for their generous support to the Foundation. I appeal them for the similar support in the coming years.

I am thankful to the Benevolent Donors, Members of the Board of Trustees, Members of Research Advisory and Ethics Committee and Honorary Consultants for their kind help and support to this Foundation. I am also happy that all Medical, Paramedical, Administrative and all other Categories of staff have sincerely contributed to the development of the Foundation.

Independent Auditor's Report

To

Opinion

We have audited the financial statements of **DR JIVRAJ MEHTA SMARAK HEALTH FOUNDATION**, Bakeri Medical Research Centre (**the “Trust”**) which comprise the Balance Sheet at 31st March, 2020 and the Income and Expenditure Account for the year then ended in which are included their Units (**Health Care Unit & Research Unit**) which are separately audited by us, and notes to the financial statements, including a summary of Significant Accounting Policies and other explanatory information.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the Trust as at 31st March, 2020 and excess of expenditure over income for the year then ended and are prepared, in all material respects, in accordance with The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950).

Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing (“SAs”) issued by ICAI. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Trust in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India (“ICAI”) together with the ethical requirements that are relevant to our audit of the financial statements. An audit is carried out considering the provisions of The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950) and the rules thereunder, and we have fulfilled our other

ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management of the Trust is responsible for the preparation and fair presentation of the financial statements in accordance with The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950) that give a true and fair view of the financial position and financial performance in accordance with the accounting principles generally accepted in India. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950) for safeguarding of the assets of the Trust and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgements and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management of the Trust is responsible for assessing the Trust's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the entity or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Trust's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with SAs, we exercise professional judgement and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Trust's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on our audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Trust to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with the relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

Report on Other Legal and Regulatory Requirements

As required by The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950) and on the basis of such checks as we considered appropriate and necessary and according to the information and explanations given to us, we report that:

1. The accounts are maintained regularly and in accordance with the provisions of The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950) and the Bombay Public Trusts (Gujarat) Rules, 1961.
2. The Receipts and disbursements are properly and correctly shown in the Accounts.
3. The Cash balances and vouchers are in the custody of the Cashier/Accountant on the date of audit and are in agreement with the Accounts.
4. Books, Deeds, Accounts, vouchers and other documents and records required by us were produced before us.

5. The inventory, certified by the Trustees, of the movable properties of the Trust has been maintained.
6. The Accountant-in-charge appeared before us and furnished the necessary information required by us.
7. The property or Funds of the Trust were not applied for any object or purpose other than the objects or purposes of the Trust.
8. The amounts of Advances outstanding for more than one year are Rs. Nil. and the amounts written off are Rs. 74,607/-.
9. Tenders were not invited but the quotations were obtained in most of the cases for comparative prices in respect of repairs and construction, where the expenditure exceeded Rs. 5000/- .
10. The Trust has made various investments as shown in Schedule-F to the Financial Statements aggregating to Rs. 18.32 Crore (P.Y. 16.07 Crore) as at 31st March, 2020. Investments to the extent of Rs. 5.75 Crore (P.Y. 3.5 Crore) are contrary to the provisions of Section 35 of The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950).
11. Separate books of account, records, vouchers and other documents are maintained by Healthcare Unit and Research Unit and are separately audited by us. These Units' separate Financial Statements are also attached along with Trust's Financial Statements.
12. The books of account are maintained on accrual system of accounting.

SIGNIFICANT ACCOUNTING POLICIES AND NOTES TO FINANCIAL STATEMENTS FOR THE YEAR ENDED ON 31.03.2020

(1) TRUST INFORMATION:

(a) Dr. Jivraj Mehta Smarak Health Foundation was registered under the Bombay Public Trusts Act, 1950 on 29.11.1983 having Registration No. F/951/Ahmedabad. The Foundation is also registered u/s. 12AA of the Income Tax Act, 1961 w.e.f. 29.11.1983. It also got approval u/s. 80G(5) of the Income Tax Act, 1961.

(b) The Foundation has been approved by the Central Government for the purposes of Clause (ii) of Section 35(1) of the Income Tax Act, 1961 w.e.f. 01.04.2003 in the category of "Other Institution", partly engaged in research activities vide the Notification No. 222/2007 dated 9th August, 2007 of the Govt. of India, Ministry of Finance, New Delhi.

(c) The Foundation has also received the recognition of Scientific and Industrial Research Organisations (SIROs) up to 31.03.2021 from the Government of India, Ministry of Science and Technology vide their letter No.14/127/1989-TU-V dated 4th April, 2018.

(d) The Foundation is also registered under the Foreign Contribution (Regulation) Act vide Registration No. 041910228 dated 09.06.2000, granted by the Govt. of India, Ministry of Home Affairs, Foreigners Division (FCRA Wing), New Delhi.

(e) As required under the Statute, the Foundation has maintained separate set of books of account for Research and Healthcare units, which are separately audited. Accordingly, along with consolidated financial statements, separate financial statements of Research and Healthcare units are presented herewith.

(2) METHOD OF ACCOUNTING:

Method of Accounting is on Accrual Basis.

(3) USE OF ESTIMATES:

The Preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported balances of assets and liabilities and the disclosure relating to contingent liabilities as at the date of financial statements and reported amounts of income and expenses during the reporting period. Although these estimates are based upon management's best knowledge of current events and actions, actual results could differ from those estimates. Estimates and underlying assumptions are reviewed at each Balance Sheet date. Revisions to accounting estimates are reconized in the period in which the estimate is revised and future periods affected.

(4) FIXED ASSETS AND DEPRECIATION:

(a) Fixed Assets:

Fixed Assets have been stated at historical cost of acquisition and/or construction. The cost comprises the purchase price, including import duties and non-refundable purchase taxes and such costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

(b) Depreciation/Amortisation:

- Depreciation on Fixed Assets has been provided on written down value (WDV) method at the

rates prescribed under the Income Tax Rules, 1962.

- Lease Hold Land is amortised over the period of lease term i.e. 99 years.

(5) REVENUE RECOGNITION:

(a) Revenue is recognised when consideration can be measured reliable and there exists reasonable certainty of its recovery.

(b) Healthcare Income is recognised as and services are rendered which normally coincides when invoices are raised.

(c) Pharmacy Income is recognised as and when the medicines are sold to the patients.

(d) Interest Income is recognised on time proportion basis.

(6) INVESTMENTS:

Investments are stated at the cost price.

(7) INVENTORIES:

Inventory of Drugs, Medicines and other consumables are valued at cost, as taken, valued and certified by the management.

(8) In the opinion of the management, the current assets and loans and advances are approximately of the value stated, if realized in the ordinary course of the Trust's activities and all known liabilities have been fully provided for in the books of account unless otherwise stated.

(9) Outstanding balances as on 31st March, 2020 in respect of Sundry Credit balances, Other Liabilities, Receivables, Advances and Deposits given are subject to confirmation, reconciliation and adjustments, if any.

(10) Balances of GST Receivable are subject to reconciliation and adjustment if any.

(11) Wherever the expenses are not supported or inadequately supported by vouchers or documentary evidences, the management has certified that such expenses are genuine expenses as recorded in the books of account.

(12) Previous year's figures have been regrouped, re-arranged or re-classified wherever necessary to make them comparable with the current year's figures.
