Dear Members,

I am please to place before you the 37th Annual Report of **Dr Jivraj Mehta Smarak Health Foundation**, for the year ended on 31st March 2021, along with some of highlights of the progress and activities of the foundation, covering the period of this report.

The present covid pandemic has been a challenging time for all and Dr Jivraj Mehta Smarak Health Foundation is no exception. With the Municipal Corporation exercising statuary powers under the pandemic act and requisitioning a large part of the hospital at very poor rates for many months, a dark shadow was bound to be cast on the finances of the hospital.

With Dr Jivraj Mehta Smarak Health Foundation dedicated to functioning honestly, within the four corners of the law and with the aim of serving society, we stuck to the path of service above all else. Various charitable and other hospitals in the city also had to suffer financially.

We are however confident that with certain hard decisions we should be able to recoup the loses in sometime.

Despite the odds Dr Jivraj Mehta Smarak Health Foundation has continued to serve society and to also make plans of moving forward mainly due to the magnanimous spirit of our donors.

Despite financial adversities we continued to give subsidy to the needy patients belonging to the lower socio-economic class in indoor and OPD charges.

Medical camps were conducted in the remote backward villages of Gujarat by our medical teams for screening patients suffering from anemia, malnutrition, cataract and other diseases. Whenever needed free surgeries were also conducted.

Our blood bank, pathologists and medical staff have actively conducted blood donation camps for our indoor patients and for general requirements.

Health checkup camps for industrial workers were organized with the help of our medical team.

We were part of all the three Corona admission drives conducted by the state govt and achieved spectacular success with a 97% recovery rate.

Apart from discharging such fundamental medical services for the needy, which is the main aim of Jivraj, substantial up gradation is also being undertaken. The process of upgrading and expanding our oxygen facilities is well under way. We are also in the process of giving Dr Jivraj Mehta Smarak Health Foundation a substantial overall "facelift". Plans for starting a comprehensive gynecology department and for expanding the ICU are also well underway.

As always we look forward to your unflinching support in all ways as we march together in making Dr Jivraj Mehta Smarak Health Foundation one of the premier most medical institutions in Gujarat.

Independent Auditor's Report

Opinion

We have audited the financial statements of **DR JIVRAJ MEHTA SMARAK HEALTH FOUNDATION**, Bakeri Medical Research Centre (**the "Trust"**) which comprise the Balance Sheet at 31st March, 2021 and the Income and Expenditure Account for the year then ended in which are included their Units (**Health Care Unit & Research Unit**) which are separately audited by us, and notes to the financial statements, including a summary of Significant Accounting Policies and other explanatory information.

In our opinion, the accompanying financial statements give a true and fair view of the financial position of the Trust as at 31st March, 2021 and excess of expenditure over income for the year then ended and are prepared, in all material respects, in accordance with The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950).

Basis for Opinion

We conducted our audit in accordance with the Standards on Auditing ("SAs") issued by ICAI. Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are independent of the Trust in accordance with the Code of Ethics issued by the Institute of Chartered Accountants of India ("ICAI") together with the ethical requirements that are relevant to our audit of the financial statements. An audit is carried out considering the provisions of The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950) and the rules thereunder, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the Code of Ethics. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management of the Trust is responsible for the preparation and fair presentation of the financial statements in accordance with The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950) that give a true and fair view of the financial position and financial performance in accordance with the accounting principles generally accepted in India. This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950) for safeguarding of the assets of the Trust and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgements and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management of the Trust is responsible for assessing the Trust's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the entity or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Trust's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with SAs will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with SAs, we exercise professional judgement and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Trust's ability to continue as a going concern. If we conclude that a

material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on our audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Trust to cease to continue as a going concern.

• Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with the relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

Report on Other Legal and Regulatory Requirements

As required by The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950) and on the basis of such checks as we considered appropriate and necessary and according to the information and explanations given to us, we report that:

- 1. The accounts are maintained regularly and in accordance with the provisions of The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950) and the Bombay Public Trusts (Gujarat) Rules, 1961.
- 2. The Receipts and disbursements are properly and correctly shown in the Accounts.
- 3. The Cash balances and vouchers are in the custody of the Cashier/Accountant on the date of audit and are in agreement with the Accounts.
- 4. Books, Deeds, Accounts, vouchers and other documents and records required by us were produced before us.
- 5. The inventory, certified by the Trustees, of the movable properties of the Trust has been maintained.
- 6. The Accountant-in-charge appeared before us and furnished the necessary information required by us.
- 7. The property or Funds of the Trust were not applied for any object or purpose other than the objects or purposes of the Trust.
- 8. The amounts of Advances outstanding for more than one year are Rs. Nil. and the amounts written off are Rs. 19,246/-. (P.Y. Rs. 74,607/-)
- 9. Tenders were not invited but the quotations were obtained in most of the cases for comparative prices in respect of repairs and construction, where the expenditure exceeded Rs. 5000/-.
- 10. The Trust has made various investments as shown in Schedule-F to the Financial Statements aggregating to Rs. 17.57 Crore (P.Y. 18.32 Crore) as at 31st March, 2021. Investments to the extent of Rs. 5.00 Crore

(P.Y. 5.75 Crore) are contrary to the provisions of Section 35 of The Gujarat Public Trusts Act, 1950 (Bom. XXIX of 1950).

- 11. Separate books of account, records, vouchers and other documents are maintained by HealthcareUnit and Research Unit and are separately audited by us. These Units' separate Financial Statements are also attached along with Trust's Financial Statements.
- 12. The books of account are maintained on accrual system of accounting.

SIGNIFICANT ACCOUNTING POLICIES AND NOTES TO FINANCIAL STATEMENTS FOR THE YEAR ENDED ON 31.03.2021

(1) TRUST INFORMATION

- (a) Dr. Jivraj Mehta Smarak Health Foundation was registered under the Bombay Public Trusts Act, 1950 on 29.11.1983 having Registration No. F/951/Ahmedabad. The Foundation was also registered u/s. 12AA of the Income Tax Act, 1961 w.e.f. 29.11.1983. It also got approval u/s. 80G(5) of the Income Tax Act, 1961. The renewal applications under the new amended provisions u/s 12AB and 80G of the Income Tax Act, 1961 are being made.
- (b) The Foundation has been approved by the Central Government for the purposes of Clause (ii) of Section 35(1) of the Income Tax Act, 1961 w.e.f. 01.04.2003 in the category of "Other Institution", partly engaged in research activities vide the Notification No. 222/2007 dated 9th August, 2007 of the Govt. of India, Ministry of Finance, New Delhi.
- (c) The Foundation has also received the recognition of Scientific and Industrial Research Organisations (SIROs) up to 31.03.2021 from the Government of India, Ministry of Science and Technology vide their letter No.14/127/1989-TU-V dated 4th April, 2018. The Application for renewal of recognition of SIROs has been made in March, 2021 which is pending with the Government.
- (d) The Foundation is also registered under the Foreign Contribution (Regulation) Act vide Registration No. 041910228 dated 09.06.2000, granted by the Govt. of India, Ministry of Home Affairs, Foreigners Division (FCRA Wing), New Delhi.
- (e) As required under the Statute, the Foundation has maintained separate set of books of account for Research and Healthcare units, which are separately audited. Accordingly, along with consolidated financial statements, separate financial statements of Research and Healthcare units are presented herewith.

(2) METHOD OF ACCOUNTING:

Method of Accounting is on Accrual Basis.

(3) Use of Estimates:

The Preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported balances of assets and liabilities and the disclosure relating to contingent liabilities as at the date of financial statements and reported amounts of income and expenses during the reporting period. Although these estimates are based upon management's best knowledge of current events and actions, actual results could differ from those estimates. Estimates and underlying assumptions are reviewed at each Balance Sheet date. Any revision to accounting estimates is reconized in the period in which the estimate is revised.

(4) FIXED ASSETS AND DEPRECIATION:

(a) Fixed Assets:

Fixed Assets have been stated at historical cost of acquisition and/or construction. The cost comprises the purchase price, including import duties and non-refundable purchase taxes and such costs directly attributable to bringing the asset to the location and condition necessary for it to be capable of operating in the manner intended by management.

(b) Depreciation/Amortisation:

'- Depreciation on Fixed Assets has been provided on written down value (WDV) method at the rates precribed under the

Income Tax Rules, 1962.

'- Lease Hold Land is amortised over the period of lease term i.e. 99 years.

(5) REVENUE RECOGNITION:

- (a) Revenue is recognised when consideration can be measured reliably and there exists reasonable certainty of its recovery
- (b) Healthcare Income is recognised as and when services are rendered which normally coincides when invoices are raised.
- (c) Pharmacy Income is recognised as and when the medicines are sold to the patients.
- (d) Interest Income is recognised on time proportion basis.

(6) INVESTMENTS:

Investments are stated at the cost price.

(7) INVENTORIES:

Inventory of Drugs, Medicines and other consumables are valued at cost, as taken, valued and certified by the management.

- (8) Common expenses including depreciation/ amortisation (other than directly attributable to any specific unit) are allocated/ apportioned between Healthcare Unit and Research Unit in the ratio of 70:30 respectively.
- (9) In the opinion of the management, the current assets and loans and advances are approximately of the value stated, if realized in the ordinary course of the Trust's activities and all known liabilities have been fully provided for in the books of account unless otherwise stated.
- (10) Outstanding balances as on 31st March, 2021 in respect of Sundry Credit balances, ,Other Liabilities, Receivables, Advances and Deposits given are subject to confirmation, reconciliation and adjustments, if any.
- (11) Wherever the expenses are not supported or inadequately supported by vouchers or documentary evidences, the management has confirmed that such expenses are genuine expenses as recorded in the books of account.
- (12) Previous year's figures have been regrouped, re-arranged or re-classified wherever necessary to make them comparable with the current year's figures.
