



Dear Members,

I am pleased to place before you the 30th Annual Report of DR. JIVRAJ MEHTA SMARAK HEALTH FOUNDATION, for the year ending on 31st March, 2014, along with some of highlights of the progress and activities of the Foundation, covering the period of this report.

During the year under report the Foundation has purchased Medical Equipments, worth Rs.6,58,41,259/- Out of that major equipments purchased are for the Cath Lab Department to the tune of Rs.5,50,32,179/- which includes Heart Lungs Machine, Datascope, Anesthesia, Ventilator and Oxygen Pipe line etc. The other Medical equipments purchased includes Memography Machine worth Rs.24,00,000/-, Digital X-ray Machines worth Rs. 26,50,000/-, C.T.O.T. and S.I.C.U Equipments worth Rs 57,59,080/-.

As informed in my previous year message, Our President Shree Anilbhai Bakeri has promised to donate an amount of Rs five crores for the project of development of the Cardiology department. Foundation has made operational state of the art cathlab and cardiac surgery facilities with latest medical equipments. I am pleased to declare that from July 2013 the Cath Lab Department is in operation and carrying satisfactory progress.

I am glad to inform that , our Foundation has received the approval from Indian College of Critical Care Medicine to start Indian Diploma of Critical Care Medicine (IDCCM) and Post MBBS Certificate Course from July 2014. As per the approval Foundation can enroll two students in each category. Foundation is hopeful to enroll the students in near future.

The Foundation has been able to provide financial assistance for Healthcare to the poor, to the tune of Rs.19,95,930/- which includes an amount of Rs.14,12,200/- received from Dardionu Rahat Fund, Rs. 4,42,230/- received from Bharat Vikas Viklang Parishad and Rs. 1,41,500/- incurred from Late Shree Ratubhai Adani Poor Patient Relief Fund.

Our Research activity component has continued to do the excellent job during the year of report under the guidance of Research Advisory Committee and Ethics Committee of Research, before which are placed proposed projects every year for approval or otherwise, the interim reports of the ongoing research projects and the final report of the completed projects. During the year under report thirteen newly proposed research projects were placed before the Research Advisory Committee. Interim reports of seven ongoing projects and final reports of six completed Research Projects were also placed before the Research Advisory Committee. The Institution has been involved in Clinical,

Laboratory, Field research projects etc.

We intend to continue to widen the spectrum of Research & Health care activity, continuing our efforts of development in future.

Our Foundation has continued its efforts during this financial year, as in the past in its mission of serving and providing good health care to the community at large and undertaking Research activities with support of all concerned.

I am thankful to the Benevolent Donors, Members of the Board of Trustees, Governing Council, Members of Research Advisory and Ethics Committee and Honorary Consultants for their kind help and support to this Foundation. I am also happy that all Medical, Paramedical, Administrative and all other Categories of staff have sincerely contributed to the development of the Foundation.
