**Dear Members,**

I am pleased to place before you the 32<sup>nd</sup> Annual Report of DR. JIVRAJ MEHTA SMARAK HEALTH FOUNDATION, for the year ending on 31<sup>st</sup> March, 2016, along with some of highlights of the progress and activities of the Foundation, covering the period of this report.

I am pleased to announce that during the year the foundation has received the Research Corpus Donation to the tune of Rs. 71,77,501/- against that the Foundation has purchased Medical Equipment, worth Rs. 86,53,547/- Which includes Thunder Beat, Anesthesia work station, I.I.T.V. Machine, Trademill machine, etc. Further, window base software and modernization of Histopathology department with Microtome & Floatation bath has resulted in fast reporting and improving the quality of pathology department in diagnoses of the diseases.

With good team effort, the foundation has received the Renewal Registration of Kidney Transplantation under Transplantation of Human Organ Act 1994 - for performing Kidney Transplantation for period of five years.

I am pleased to inform that the foundation along with the Blood Bank operation at the premises, efforts are being undertaken to expand the Whole Blood Bank by adding the Blood Component Laboratory (Blood Transfusion Medicine Department). Required civil work is completed and equipments are already ordered. The department by the end of this year will be in full operation. The Blood Bank is being put up at an investment of about Rs. 1.00 crore. Operation of Blood Bank will ensure availability of blood and blood components so that treatment may not get delayed. Foundation all the times looks at the requirement of the Poor Patients of the surrounding areas and to ensure that services are provided at most reasonable rates to the poor patients.

The foundation is being fortunate to get the support of the Donors and I am thankful to our Donors for their generous support to the Foundation. I appeal them for the similar support in the coming years.

The Foundation has been able to provide financial assistance for Healthcare to the poor, to the tune of Rs. 33,51,228/- which includes a relief received by the patient of Foundation to the tune of Rs. 26,27,200/- from Dardionu Rahat Fund, Rs. 4,44,615/- received from Bharat Vikas Viklang Parishad and direct relief from the Late Shree Ratubhai Adani Poor Patient Relief Funds Rs. 2,79,413/-.

Our Research activity component has continued to do the excellent job during the year of report under the guidance of Research Advisory Committee and Ethics Committee of Research, before which are placed proposed projects every year for approval or otherwise, the interim reports of the ongoing research projects and the final report of the completed projects. During the year under report nine newly proposed research projects were placed before the Research Advisory Committee. Interim reports of eight ongoing projects and final reports of five completed Research Projects were also placed before the Research Advisory Committee. The Institution has been involved in Clinical, Laboratory, Field research projects etc.

We intend to continue to widen the spectrum of Research & Health care activity, continuing our efforts of development in future.

Our Foundation has continued its efforts during this financial year, as in the past in its mission of serving and providing good health care to the community at large and undertaking Research activities with support of all concerned.

I am thankful to the Benevolent Donors, Members of the Board of Trustees, Governing Council, Members of Research Advisory and Ethics Committee and Honorary Consultants for their kind help and support to this Foundation. I am also happy that all Medical, Paramedical, Administrative and all other Categories of staff have sincerely contributed to the development of the Foundation.
